Dear Senator Jones and Representative Lumsden:

Pursuant to provisions of the O.C.G.A. regarding legislative review of proposed executive branch agency rules, the attached notice of proposed rule action by the above-referenced agency has been assigned to your standing committees, and I am transmitting herewith a copy for your review.

No action is required of your committee. However, subject to certain procedures and deadlines specified by law, either committee (or both) may, by vote thereof, decide to file an objection to a proposed rule.¹ If either committee timely objects and the agency adopts the proposed rule despite such objection, then the General Assembly may override such rule by means of adopting a resolution. Other procedures may apply as well.

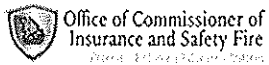
