NOTICE OF INTENT TO ADOPT RULE CHANGES AND NOTICE OF HEARING

Notice is hereby given, pursuant to the Georgia Administrative Procedure Act, O.C.G.A. Sections 50-13-3,50-13-4, 50-13-6, 50-13-21, and pursuant to O.C. G.A. Sections 8-2-132 and 8 2-161(1), of the following proposal by the Insurance and Safety Fire Commissioner "the Commissioner") to amend the Rules and Regulations of the Office of the Commissioner of Insurance and Safety Fire.

The Rules and Regulations of the Commissioner of Insurance and Safety Fire are proposed to be amended by the following actions:

-Repealing Regulation 120-3-7-.08, entitled "Annual License," and in lieu thereof, adopt ing a new Regulation 120-3-7-.08, entitled "Annual License."

SYNOPSIS AND EXPLANATION OF PROPOSED RULE CHANGES

Current regulations dealing with issuance of licenses for the manufacture, sale, and installation of manufactured homes provide for the issuance of temporary licenses for installers and for the hiring of nonlicensed persons by licensed installers under certain circumstances. Current regulations also provide that annual renewal notices must be sent to licensees by United States mail, and that a hearing must be held before a license application is denied or before an order of suspension or revocation is issued. The proposed amendments would do the following:

Eliminate the use of temporary licenses and create the designation of "authorized ac countable personnel" for persons who have completed training approved by the Commissioner, and who may then be employed by licensed installers;

Replace the requirement for mailing renewal notices to licensees with a requirement that such notices be sent by email;

Clarify the requirements for notifying applicants and licensees of license refusals, suspensions, and revocations, and provide for notice of the opportunity of a hearing in such actions in accordance with the Georgia Administraive Procedure Act and applicable regulations.

Based upon full consideration of all written and oral comments regarding the above matters, the Commissioner of insurance and Safety Fire may reject or adopt the proposed rules or make changes to the proposed rules which may require another rulemaking hearing.
